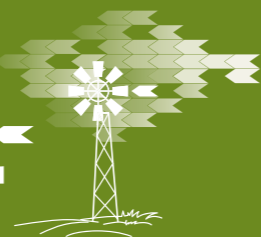

Apparent Tebuthiuron 200 HERBICIDE

STORAGE AND DISPOSAL

Store in the closed original container in a dry, cool well-ventilated area out of direct sunlight. DO NOT store near food, feedstuffs, fertilisers or seed. Do not dispose of granules on-site. Shake bag contents into application equipment until the bag is empty. Do not dispose of undiluted chemicals on-site. Puncture or shred and bury empty bags in a local authority landfill. If no landfill is available, bury the containers below 500 mm in a disposal pit specifically marked out and set up for this purpose clear of waterways, desirable vegetation and tree roots. Empty bags and product should not be burnt.

SMALL SPILL MANAGEMENT

Sweep up material for disposal and contain in a refuse vessel for disposal (see Storage and Disposal Section).

SAFETY DIRECTIONS

Harmful if swallowed. Will irritate the eyes. Repeated exposure may cause allergic disorders. Avoid contact with eyes and skin. When opening the container and preparing the

product and using the prepared product, wear cotton overalls buttoned to the neck and wrist and a washable hat and elbow-length chemical resistant gloves. Wash hands after use. After each day's use wash gloves and contaminated clothing.
