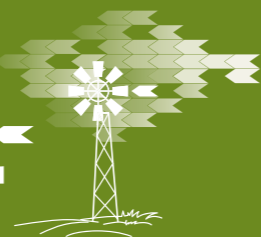

STORAGE AND DISPOSAL

Store in the closed, original container in a cool, well-ventilated area. DO NOT store for prolonged periods in direct sunlight. Triple rinse containers before disposal. Add rinsings to spray tank. DO NOT dispose of undiluted chemicals on-site. If recycling, replace cap and return clean containers to recycler or designated collection point. If not recycling, break, crush or puncture and deliver empty packaging for appropriate disposal to an approved waste management facility. If an approved waste management facility is not available, bury the empty packaging 500mm below the surface in a disposal pit specifically marked and set up for this purpose clear of waterways, desirable vegetation and tree roots, in compliance with relevant Local, State or Territory government regulations. DO NOT burn empty containers or product.

Returnable containers: Empty contents fully into application equipment. Close all valves and return to point of supply for refill or storage.

SAFETY DIRECTIONS

Will irritate the eyes, nose, throat and skin. Do not inhale vapour. Avoid contact with eyes and skin. Repeated exposure may cause allergic disorders. When opening the container and preparing the spray, wear cotton overalls buttoned to the neck and wrist, a washable hat, elbow-length chemical resistant gloves and

a face shield or goggles. If clothing becomes contaminated with product, remove clothing immediately. If product on skin, immediately wash the area with soap and water. Wash hands after use. After each day's use, wash gloves, face shield or goggles and contaminated clothing.
