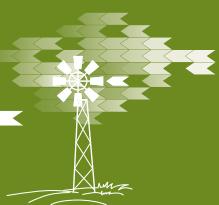

STORAGE AND DISPOSAL

Store in the closed, original container in a cool, well ventilated area. Do not store for prolonged periods in direct sunlight. Triple rinse containers before disposal. Add rinsings to spray tank. DO NOT dispose of undiluted chemicals on site. If recycling, replace cap and return clean containers to recycler or designated collection point. If not recycling, break, crush, or puncture and deliver empty packaging for appropriate disposal to an approved waste management facility.

If an approved waste management facility is not available bury the empty packaging 500mm below the surface in a disposal pit specifically marked and set up for this purpose clear of waterways, desirable vegetation and tree roots, in compliance with relevant Local, State or Territory government regulations. DO NOT burn empty containers or product. Do not reuse empty container for any other purpose.

When opening the container, mixing and loading and preparing spray, wear cotton overalls buttoned to the neck and wrist (or equivalent clothing), and elbow length chemical resistant gloves.
